


Figure 1. Example of Empower SystemsQT Test Selection screen and Empower Run Samples.

By leveraging system-level testing, Empower SystemsQT combines module-level testing, eliminating manual tests predominantly used today.

Empower SystemsQT is developed specifically with a particular system in mind. This ensures that no documentation needs to be generated other than what is required. Review of copious amounts of unrequired documents is prevalent when using 'universal' or 'multi-vendor' qualification tools.

Waters Compliance Specialists are trained in Agilent 7890 and 8890 GC systems operation and maintenance procedures under Empower Software control. You can reduce downtime of GC systems in a regulated environment by requiring scheduled maintenance to be performed prior to qualification.

TRANSPARENCY AND STANDARDIZATION

Does your qualification process demonstrate clear transparency as to how testing was done?

A lack of procedural detail is a risk at time of audit. Empower SystemsQT has specific protocol and test descriptions and all methods are available to view in Empower Software. Avoid minimal descriptions and procedures by vendors stating that it is not a regulatory requirement to have them.

It is easier to demonstrate compliance when systems have been qualified using a standardized template. Empower SystemsQT allows for the standardization of all qualification for Waters ACQUITY™ UPLC™ and HPLC systems, and Agilent 1260 HPLC systems, 1290 UHPLC systems, and 7890 and 8890 GC systems.




Figure 2. Example of a typical Empower Agilent GC Instrument Method Editor.
